

\*\*\*NEW BYLAWS AS OF MARCH 2ND 2016\*\*\*

AS A MATTER OF TRANSPARENCY SOME ADDITIONAL CHANGES TO THE BYLAWS WERE MADE NONE OF WHICH EXCEPT THE ACTUAL AMENDMENT CHANGES THE THE DOCUMENTS INTENT IN ANY WAY.

CHANGES INCLUDED ARE:

1. THE ENTIRE DOCUMENT WAS CHANGED TO CENTER AND CAPITOL LETTERS TO UNIFY FORMAT ON THE PRINTED COPIES (DOES NOT APPEAR ON WEB SITE DUE TO FORMATTING ISSUES)
2. CHANGES OF GRAMMAR, SPELLING OR DEFINITION TO CLARIFY A TERM ALREADY USED IN THE DOCUMENT
3. THE APPROVED AMENDMENT TO ARTICLE III SECTION TWO AS PER MAJORITY VOTE ON MARCH 2ND 2016 AT 34 YEA TO 29 NAY

NEW BYLAWS AS PUBLISHED:  
NEW SPORTSMAN'S CLUB BY-LAWS  
(AS ADOPTED MARCH 2, 2016)

#### ARTICLE I

1. THIS CLUB SHALL BE A VOLUNTARY ASSOCIATION OF MEMBERS WHO SHALL BECOME AFFILIATED AS PROVIDED LATER IN THESE BY- LAWS, AND SHALL BE NAMED THE NEW SPORTSMAN'S CLUB.

#### ARTICLE II

##### PURPOSE

1. THE OBJECT OF THE NEW SPORTSMAN'S CLUB SHALL BE TO PROMOTE THE SAFE AND EFFICIENT USE OF FIREARMS AND HUNTING EQUIPMENT AMONG MEMBERS AND THEIR GUESTS, AND TO FURTHER AID DEVELOPMENT OF HONESTY, FELLOWSHIP, SELF-DISCIPLINE AND RELIANCE AMONG ALL SPORTSMEN.

#### ARTICLE III

##### MEMBERSHIP

1. ANY PERSON 21 YEARS OF AGE OR OLDER THAT IS SPONSORED BY A MEMBER IN GOOD STANDING AND IS A NRA MEMBER, OR THAT JOINS THE NRA ON OR BEFORE THEIR HAVING BEEN VOTED IN AS PROBATIONARY MEMBERS, MAY BECOME A PROBATIONARY MEMBER OF THIS ORGANIZATION HAVING COMPLETED THE FOLLOWING, ATTENDED NO LESS THAN TWO (2) MEETINGS WITHIN A 2 QUARTER PERIOD, VOTED IN BY THE MAJORITY, AND PAYING ALL DUES AND FEES (INCLUDING NRA DUES IF NOT AN ACTIVE NRA MEMBER). FOR THOSE MEMBERS WHO JOIN IN THE LAST QUARTER OF THE YEAR, DUES & FEES (EXCEPT NRA DUES) WILL CARRY OVER AS THOUGH THEY JOINED IN JANUARY.

2. ALL MEMBERS SHOULD UNDERSTAND THEIR OBLIGATION OF PARTICIPATION TO THE CLUB: MEMBERS ARE EXPECTED TO REGULARLY ATTEND GENERAL MEMBERSHIP MEETINGS. A MINIMUM OF 8 WORK HOURS PER YEAR IS REQUIRED. A FEE OF \$20.00 PER WORK HOUR WILL BE ASSESSED FOR HOURS NOT COMPLETED. WORK CAN BE DONE VIA WORK PARTIES, POSTED NEEDS, OR WORKING CLUB FUNCTIONS. NEW MEMBERS WILL BE PRORATED AT THE RATE OF 2 HOURS PER QUARTER EXCEPT THOSE MEMBERS WHO JOIN IN THE LAST QUARTER. LAST QUARTER NEW MEMBERS WORK HOURS BEGIN IN JANUARY AND ANY WORK HOURS COMPLETED IN THE LAST QUARTER WILL CARRY OVER TO THE FIRST FULL YEAR OF MEMBERSHIP FOR A MINIMUM OF 8 WORK HOURS.

3. ALL MEMBERS OF THE NEW SPORTSMAN'S CLUB ARE REQUIRED TO BE MEMBERS OF THE

NATIONAL RIFLE ASSOCIATION OF AMERICA (THE NATIONAL RIFLE ASSOCIATION IS ALSO COMMONLY REFERRED TO AS THE NRA). FAILURE TO MAINTAIN A FULLY PAID-UP MEMBERSHIP IN THE NATIONAL RIFLE ASSOCIATION IS CAUSE FOR TERMINATION OF MEMBERSHIP IN THE NEW SPORTSMAN'S CLUB.

4. PROBATIONARY MEMBERS ARE CONSIDERED TO BE MEMBERS IN GOOD STANDING WITH THE FOLLOWING RESTRICTIONS:

A. THE RIGHT TO USE ANY OUTDOOR OR INDOOR RANGE, APART FROM EVENTS OPEN TO THE GENERAL PUBLIC, UNLESS AS A GUEST OF A MEMBER IN GOOD STANDING.

B. AFTER A SIX MONTH PERIOD THE STATUS OF THE PROBATIONARY MEMBERSHIP SHALL BE CHANGED TO MEMBER IN GOOD STANDING, PROVIDING THAT THE PROBATIONARY MEMBER HAS NOT BEEN SUSPENDED OR EXPELLED AS PROVIDED IN THESE BYLAWS.

C. AFTER THE SIX MONTH PROBATIONARY PERIOD EXPIRES ANY NEW MEMBER IN GOOD STANDING WHOSE PROBATIONARY TERM EXPIRES IN THE FIRST OR SECOND QUARTERS SHALL BE GRANTED THE RIGHT TO NOMINATE 1 INDIVIDUAL FOR MEMBERSHIP IN THE NEW SPORTSMAN'S CLUB DURING THE REMAINDER OF THE CALENDAR YEAR. ANY NEW MEMBER IN GOOD STANDING WHOSE PROBATIONARY PERIOD ENDS IN THE THIRD OR FOURTH QUARTERS OF THE YEAR. SHALL BE GRANTED THE RIGHT TO NOMINATE 1 INDIVIDUAL FOR MEMBERSHIP IN THE NEW SPORTSMAN'S CLUB DURING THE REMAINDER OF THE CALENDAR YEAR.

5. MEMBERS IN GOOD STANDING HAVE THE FOLLOWING PRIVILEGES NOT AFFORDED TO PROBATIONARY MEMBERS OR MEMBERS WHO ARE DELINQUENT OR ARE MEMBERS NOT IN GOOD STANDING:

A. THE RIGHT TO NOMINATE 2 INDIVIDUALS FOR MEMBERSHIP IN THE NEW SPORTSMAN'S CLUB ANNUALLY.

B. THE RIGHT TO USE ANY OUTDOOR OR INDOOR RANGE (INCLUDING THE HUNTING PROPERTY IN ATHENS), APART FROM EVENTS OPEN TO THE GENERAL PUBLIC.

C. THE RIGHT TO PREFER CHARGES AGAINST ANY OFFICER OR MEMBER.

D. THE RIGHT TO VOTE AT GENERAL OR SPECIAL MEETINGS ON THE SUSPENSION OR EXPULSION OF ANY MEMBER.

E. THE RIGHT TO VOTE ON THE REMOVAL OF AN OFFICER.

#### ARTICLE IV

##### MEMBERSHIP FEES

1. AS OF JANUARY 1, 2010, THE FOLLOWING FEES SHALL BE IN EFFECT FOR THE NEW SPORTSMAN'S CLUB:

A. AN INITIATION FEE FOR ALL NEW MEMBERS SHALL BE \$20.00.

B. A KEY FEE OF \$20.00 FOR ISSUANCE OF ACCESS ITEMS (KEYS, FOB OR KEY CARD(S) TO THE NEW SPORTSMAN'S CLUB. SUCH ACCESS ITEMS ARE AND WILL REMAIN THE PROPERTY OF THE NEW SPORTSMAN'S CLUB, AND SHALL BE RETURNED TO NEW SPORTSMAN'S CLUB UPON REQUEST, RESIGNATION, SUSPENSION, EXPULSION, OR OTHER TERMINATION OF MEMBERSHIP.

C. AN ANNUAL FEE OF \$17.00 FOR THE PURPOSE OF LIABILITY INSURANCE. THIS MAY FLUCTUATE ANNUALLY, AT WHICH TIME THE EXECUTIVE COMMITTEE SHALL HAVE THE AUTHORITY TO ALTER THE FEE AS DEEMED NECESSARY.

D. NEW SPORTSMAN'S CLUB ANNUAL DUES OF \$28.00 FOR A TERM ENDING THE DATE OF THE NEXT DECEMBER MEETING.

E. AN ANNUAL FEE SUFFICIENT TO INSTALL THE MEMBER ANNUALLY AS A MEMBER OF THE NATIONAL RIFLE ASSOCIATION. THE EXECUTIVE COMMITTEE SHALL HAVE THE AUTHORITY TO ALTER THE FEE AS DEEMED NECESSARY. THIS FEE MAY BE WAIVED IF A MEMBER PROVIDES EVIDENCE OF BEING A MEMBER OF THE NATIONAL RIFLE ASSOCIATION, AND THE MEMBER CONTINUES TO SEPARATELY MAINTAIN THEIR MEMBERSHIP IN THE NATIONAL RIFLE ASSOCIATION DURING THEIR MEMBERSHIP IN THE NEW SPORTSMAN'S CLUB. THIS FEE MAY BE ASSESSED UPON FAILURE OF THE MEMBER TO MAINTAIN A FULLY PAID-UP MEMBERSHIP IN THE NATIONAL RIFLE ASSOCIATION.

F. DUES SHALL BE COLLECTED NO LATER THAN JANUARY 31ST OF EACH CALENDAR YEAR. DUES PAID AFTER JANUARY 31ST SHALL BE ASSESSED A \$20.00 LATE FEE IN ADDITION TO MEMBERSHIP FEES, NRA MEMBERSHIP FEES, UNCOMPLETED WORK HOURS OR ANY OTHER DEBT TO THE CLUB. MEMBERS WILL BE CONSIDERED DELINQUENT ON PAYMENT OF ANY OF THE FORGOING FEES IF NOT PAID IN FULL BY THE END OF THE REGULAR FEBRUARY MEETING. AFTER THE REGULAR MARCH MEETING ANNUALLY, ANY MEMBER CONSIDERED DELINQUENT WILL AUTOMATICALLY BE RESIGNED FROM THE MEMBERSHIP OF THE CLUB DUE TO INACTION. IF A MEMBER IS RESIGNED DUE TO INACTION & CAN SHOW THAT EXTENUATING CIRCUMSTANCES EXISTED THAT WOULD HAVE CREATED A REASONABLE HARDSHIP, THE BOARD MAY AT ANY MEETING WHERE THE PRESIDENT OR VICE PRESIDENT AND ANY TWO MEMBERS OF THE EXECUTIVE BOARD ARE IN ATTENDANCE, BY MAJORITY VOTE MAY RULE TO REINSTATE THE MEMBER WITH OR WITHOUT PENALTY.

## ARTICLE V

### MEETINGS

1. THE ANNUAL MEETING OF THE NEW SPORTSMAN'S CLUB FOR ELECTION OF OFFICERS FOR THE FORTHCOMING TERMS WILL BE THE NOVEMBER REGULAR MEETING, AND INCUMBENTS SHALL REMAIN IN OFFICE UNTIL JANUARY 1. AT THIS TIME TREASURER'S REPORTS, SECRETARIAL MINUTES AND ALL OTHER PERTINENT DATA COMPILED SHALL BE TURNED OVER TO THEIR SUCCESSORS IN PROPER ORDER.

2. REGULAR MEETINGS SHALL BE HELD THE FIRST WEDNESDAY OF EACH MONTH FOR TRANSACTION OF ORDINARY BUSINESS. UPON MAJORITY VOTE BY THE MEMBERS ATTENDING A REGULAR MEETING, THE TIME AND DATE FOR A SUBSEQUENT REGULAR MEETING MAY BE CHANGED; IN SUCH CASE, THE SECRETARY WILL NOTIFY THE MEMBERSHIP, IN SOME SUITABLE MANNER TO BE DETERMINED BY THE EXECUTIVE COMMITTEE, NOT LESS THAN SEVEN [7] DAYS PRIOR TO THE EARLIER OF THE ORIGINAL OR RESCHEDULED DATES OF THE SUBSEQUENT MEETING.

3. SPECIAL MEETINGS MAY BE HELD BY ORDER OF THE PRESIDENT OR UPON DEMAND IN WRITING, STATING THE OBJECT OF PROPOSED MEETING, SIGNED BY NOT LESS THAN ONE-THIRD [1/3] OF THE TOTAL NUMBER OF MEMBERS ENTITLED TO VOTE UPON THE PROPOSED SUBJECT MATTER OF THE MEETING. NOTICE OF TIME AND OBJECT OF ANY SPECIAL MEETING SHALL BE GIVEN TO ALL OFFICERS AND MEMBERS IN SOME SUITABLE MANNER TO BE DETERMINED BY THE EXECUTIVE COMMITTEE, NOT LESS THAN SEVEN [7] DAYS PRIOR TO FIXED DATE OF SAID MEETING.

4. FIFTEEN [15] MEMBERS OF THE NEW SPORTSMAN'S CLUB OR FOUR [4] MEMBERS OF THE EXECUTIVE COMMITTEE CONSTITUTES A QUORUM AT ANY MEETING.

## ARTICLE VI

### OFFICERS

1. THE OFFICERS OF THE NEW SPORTSMAN'S CLUB SHALL BE A PRESIDENT, VICE-PRESIDENT, SECRETARY, MEMBERSHIP SECRETARY, TREASURER, AN INDOOR RANGE CAPTAIN, AN OUTDOOR RANGE CAPTAIN, A SERGEANT-AT-ARMS, AND TWO TRUSTEES. UNDER A TWO-YEAR TENURE OF OFFICE PER POSITION AND SHALL BE ELECTED BY MAJORITY VOTE OF CLUB MEMBERS. ELECTIONS FOR PRESIDENT, TREASURER, INDOOR RANGE CAPTAIN, SERGEANT-AT-ARMS, MEMBERSHIP SECRETARY AND ONE TRUSTEE ON ODD NUMBER YEARS. ELECTIONS WILL BE HELD FOR VICE-PRESIDENT SECRETARY, OUTDOOR RANGE CAPTAIN, AND REMAINING TRUSTEE ON EVEN NUMBER YEARS.

2. THE EXECUTIVE COMMITTEE SHALL HAVE GENERAL SUPERVISION AND CONTROL OF ALL THE ACTIVITIES OF THE CLUB.

3. MEETINGS OF THE EXECUTIVE COMMITTEE SHALL BE HELD REGULARLY AT SUCH TIME AND PLACE AS THE COMMITTEE MAY DETERMINE. SPECIAL MEETINGS OF THE EXECUTIVE COMMITTEE MAY BE HELD AT ANY TIME ON THE CALL OF THE PRESIDENT OR ON DEMAND, IN WRITING, TO THE SECRETARY BY THREE [3] MEMBERS OF THE COMMITTEE.

4. A VACANCY IN THE EXECUTIVE COMMITTEE MAY BE FILLED BY A MAJORITY VOTE OF THE REMAINING MEMBERS OF THE COMMITTEE. HOWEVER, IF MORE THAN ONE VACANCY EXISTS, A SPECIAL MEETING OF THE CLUB SHALL BE CALLED AND NEW OFFICERS SHALL BE ELECTED TO FILL THE VACANCIES UNTIL THE DATE OF THE NEXT ANNUAL MEETING AS PROVIDED IN ARTICLE V, PARAGRAPH 1.

## ARTICLE VII

### DUTIES OF OFFICERS

1. PRESIDENT. THE PRESIDENT SHALL PRESIDE AT ALL MEETINGS OF THE CLUB AND OF THE EXECUTIVE COMMITTEE. HE SHALL BE A MEMBER EX-OFFICIO OF ALL REGULAR AND SPECIAL COMMITTEES AND SHALL PERFORM ALL SUCH OTHER DUTIES AS USUALLY PERTAIN TO HIS OFFICE.

2. VICE-PRESIDENT. THE VICE-PRESIDENT SHALL PERFORM THE DUTIES OF THE PRESIDENT IN HIS ABSENCE OR AT HIS REQUEST.

3. SECRETARY. THE SECRETARY SHALL KEEP A TRUE RECORD-OF ALL MEETINGS OF THE EXECUTIVE COMMITTEE AND OF THE CLUB AND SHALL HAVE CUSTODY OF THE CLUB'S BOOKS AND RECORDS EXCEPT THOSE OF THE TREASURER.

4. MEMBERSHIP SECRETARY. ALL APPLICATIONS FOR MEMBERSHIP WILL BE MADE TO THE MEMBERSHIP SECRETARY. THE MEMBERSHIP SECRETARY SHALL BE RESPONSIBLE FOR THE COLLECTION OF ALL DUES AND SHALL PAY THE SAME TO THE TREASURER. THE MEMBERSHIP SECRETARY SHALL MAINTAIN A ROSTER OF MEMBERS AND A RECORD OF PROBATIONARY MEMBERS, MEMBERS IN GOOD STANDING, DELINQUENT MEMBERS, SPONSORSHIP RECORDS, NRA MEMBERSHIP, AND RECORDS OF MEMBERS WHO ARE NOT IN GOOD STANDING AS PER THE CONDITIONS OF THESE BYLAWS.

5. TREASURER. THE TREASURER SHALL HAVE CHARGE OF ALL FUNDS OF THE CLUB AND PLACE THE SAME IN SUCH BANK OR BANKS AS MAY BE APPROVED BY THE EXECUTIVE COMMITTEE. SUCH MONEY SHALL ONLY BE WITHDRAWN BY CHECK SIGNED BY THE TREASURER AND FOR THE PAYMENT OF SUCH BILLS AS SHALL HAVE BEEN APPROVED BY THE EXECUTIVE COMMITTEE.

6. INDOOR RANGE CAPTAIN. THE INDOOR RANGE CAPTAIN SHALL HAVE CHARGE OF THE INDOOR RANGES OF THE CLUB, THE PRINTING OF SCOREBOARDS, THE ARRANGING OF INDOOR COMPETITIONS, ETC. HE SHALL CONTRACT NO BILLS WITHOUT THE AUTHORIZATION OF THE EXECUTIVE COMMITTEE.

7. OUTDOOR RANGE CAPTAIN. THE OUTDOOR RANGE CAPTAIN SHALL HAVE CHARGE OF THE OUTDOOR RANGES OF THE CLUB, THE PRINTING OF SCOREBOARDS, THE ARRANGING OF OUTDOOR COMPETITIONS, ETC. HE SHALL CONTRACT NO BILLS WITHOUT THE AUTHORIZATION OF THE EXECUTIVE COMMITTEE.

8. TRUSTEE. THE TWO TRUSTEES' DUTIES SHALL BE TO AUDIT THE TREASURER'S BOOKS BY ONE AUDIT ANNUALLY WITH AT LEAST TWO OTHER MEMBERS, OTHER THAN THE TREASURER, OF THE EXECUTIVE COMMITTEE, AND ONE NON-OFFICER PICKED BY THE MEMBERSHIP. THE RESULTS OF THE ANNUAL AUDIT SHALL BE REPORTED TO THE MEMBERSHIP AT A REGULAR MEETING.

9. SERGEANT-AT-ARMS. THE SERGEANT-AT-ARMS DUTIES SHALL BE TO TAKE ATTENDANCE AT ALL CLUB MEETINGS AND FUNCTIONS. ADDITIONALLY, THE SERGEANT-AT-ARMS SHALL KEEP RECORDS OF WORK HOURS PERFORMED BY MEMBERS. THE SERGEANT-AT-ARMS WILL MAKE A REPORT OF

MEMBER ATTENDANCE AND WORK HOURS AVAILABLE FOR INSPECTION AT EACH REGULAR MEETING.

#### ARTICLE VIII

#### SUSPENSION OR EXPULSION

1. SUSPENSION. SUSPENSION MEANS A TEMPORARY REVOCATION OF ALL OR PART OF MEMBERSHIP RIGHTS IN THE NEW SPORTSMAN'S CLUB FOR A PERIOD OF TIME NOT TO EXCEED 45 DAYS. THE TERM OF MEMBERSHIP CONTINUES TO RUN DURING THE PERIOD OF SUSPENSION, SUCH THAT THE TERM OF MEMBERSHIP EXPIRES UPON JANUARY 1ST OF THE FOLLOWING YEAR. A SUSPENDED MEMBER MAY BE REQUIRED TO RETURN ANY CLUB PROPERTY ISSUED TO THE MEMBER. UPON THE TERMINATION OF THE SUSPENSION, PROVIDED THAT A SUSPENDED MEMBER IS NOT EXPELLED, AND THE TERM OF MEMBERSHIP IS NOT EXPIRED, THE RIGHTS OF THE MEMBER ARE RESTORED.

2. EXPULSION. EXPULSION MEANS AN IMMEDIATE TERMINATION OF MEMBERSHIP IN THE NEW SPORTSMAN'S CLUB, WITH LOSS OF ALL RIGHTS AND PRIVILEGES. AN EXPELLED MEMBER SHALL RETURN ANY CLUB PROPERTY ISSUED TO THE EXPELLED MEMBER.

3. THERE IS NO REFUND OF ANY PORTION OF ANY FEES COLLECTED BY THE NEW SPORTSMAN'S CLUB FROM A MEMBER, OR PROBATIONARY MEMBER WHO IS SUSPENDED OR EXPELLED.

4. ANY OFFICER MAY BE REMOVED BY A TWO-THIRDS VOTE OF THE MEMBERS IN GOOD STANDING PRESENT AT ANY SPECIAL MEETING CALLED FOR THIS PURPOSE. NO VOTE ON REMOVAL MAY BE TAKEN UNLESS AT LEAST FIFTEEN DAYS NOTICE IN WRITING SHALL HAVE BEEN GIVEN TO THE OFFICER OF THE REASONS FOR HIS REMOVAL AND OF THE TIME AND PLACE OF THE SPECIAL MEETING AT WHICH SUCH BALLOT ON HIS REMOVAL IS TO BE TAKEN. AT SUCH MEETING, THE OFFICER SHALL BE GIVEN A FULL HEARING.

5. ANY MEMBER MAY BE SUSPENDED OR EXPELLED FROM THE CLUB FOR ANY CAUSE DEEMED SUFFICIENT BY THE EXECUTIVE COMMITTEE BY A TWO-THIRDS [2/3] AFFIRMATIVE VOTE OF THE MEMBERS OF THE EXECUTIVE COMMITTEE PRESENT AT ANY REGULAR OR SPECIAL MEETING OF THE EXECUTIVE COMMITTEE. NO VOTE OF EXPULSION MAY BE TAKEN UNLESS AT LEAST FIFTEEN [15] DAYS NOTICE IN WRITING SHALL HAVE BEEN GIVEN TO THE MEMBER OF THE CHARGES REFERRED AND OF THE TIME AND PLACE OF THE MEETING OF THE EXECUTIVE COMMITTEE AT WHICH SUCH CHARGES WILL BE CONSIDERED. AT SUCH MEETING THE MEMBER UNDER CHARGES WILL BE ACCORDED A FULL HEARING.

6. CHARGES AGAINST ANY OFFICER OR MEMBER MAY BE PREFERRED BY ANY MEMBER IN GOOD STANDING. THEY SHALL BE IN WRITING CLEARLY STATING THE FACTS RELIED UPON AND ACCOMPANIED BY ALL AFFIDAVITS OR EXHIBITS WHICH ARE TO BE USED IN THEIR SUPPORT. SUCH CHARGES SHALL BE FILED WITH THE SECRETARY, WHO WILL IMMEDIATELY NOTIFY THE PRESIDENT. THE PRESIDENT WILL CALL A MEETING OF THE EXECUTIVE COMMITTEE TO HEAR THE CHARGES. THE SECRETARY WILL GIVE AT LEAST FIFTEEN [15] DAYS NOTICE OF THE MEETING TO EACH MEMBER OF THE EXECUTIVE COMMITTEE AND TO THE ACCUSER AND TO THE ACCUSED, WHICH NOTICE SHALL BE IN WRITING AND WILL INCLUDE A TRUE COPY OF THE CHARGES AND OF THE SUPPORTING AFFIDAVITS AND EXHIBITS.

7. ANY MEMBER OR PROBATIONARY MEMBER THAT IS SUSPENDED OR EXPELLED BY THE EXECUTIVE COMMITTEE MAY APPEAL TO THE FULL MEMBERSHIP OF THE CLUB. SUCH APPEAL SHALL BE MADE IN WRITING TO THE SECRETARY WHO WILL NOTIFY THE PRESIDENT, THE PRESIDENT WILL CALL A SPECIAL MEETING' OF THE CLUB FOR THE PURPOSE OF ACTING ON THE APPEAL. THE SECRETARY SHALL GIVE AT LEAST FIFTEEN [15] DAYS NOTICE IN WRITING TO ALL MEMBERS OF THE CLUB IN GOOD STANDING, STATING THE DATE, TIME, PLACE AND REASON FOR SPECIAL MEETING. AT THE MEETING OF THE FULL CLUB, THE SECRETARY WILL READ THE ORIGINAL CHARGES, THE SUPPORTING AFFIDAVITS AND WILL READ OR DISPLAY THE ACCOMPANYING EXHIBITS AND WILL READ THE MINUTES OF THE SPECIAL MEETING OF THE EXECUTIVE COMMITTEE AT WHICH THE CHARGES WERE HEARD AND ACTION TAKEN. A FULL HEARING WILL BE GIVEN THE ACCUSER AND THE ACCUSED. A VOTE WILL BE TAKEN BY BALLOT OF THE MEMBERS IN GOOD STANDING PRESENT AND A TWO-THIRDS [2/3] VOTE SHALL BE REQUIRED TO REVERSE THE ACTION OF THE EXECUTIVE COMMITTEE.

#### ARTICLE IX

#### AMENDMENTS

1. AMENDMENTS TO THESE BY-LAWS MAY BE PROPOSED IN WRITING BY THE EXECUTIVE COMMITTEE BY A MAJORITY VOTE AND FILED WITH THE SECRETARY. AMENDMENTS MAY ALSO BE PROPOSED BY MEMBERS ELIGIBLE TO VOTE BY PETITION CONTAINING NO LESS THAN TWELVE (12) SIGNATURES AND SHALL BE FILED IN WRITING WITH THE SECRETARY. NOTICE OF SUCH PROPOSED AMENDMENT SHALL BE GIVEN TO THE GENERAL MEMBERSHIP IN SOME SUITABLE MANNER TO BE DETERMINED BY THE EXECUTIVE COMMITTEE PRIOR TO ANY MEMBERSHIP VOTE ON SUCH PROPOSED AMENDMENTS.

2. THE PROPOSED AMENDMENT OR AMENDMENTS MUST BE READ AT TWO (2) REGULAR MEETINGS OF THE GENERAL MEMBERSHIP. A VOTE SHALL BE TAKEN AT THE SECOND GENERAL MEMBERSHIP MEETING. A TWO-THIRDS (2/3) VOTE OF THOSE MEMBERS IN ATTENDANCE AT THE MEETING SHALL BE REQUIRED TO PASS THE AMENDMENT OR AMENDMENTS BEFORE THEY MAY BE ADOPTED.

#### ARTICLE X CONCLUSION

1. A COPY OF THESE BY-LAWS SHALL BE PRESENTED TO EACH OFFICER AND EXECUTIVE BOARD MEMBER, SO THAT THEY MAY FULLY UNDERSTAND ALL OF THE REQUIREMENTS OF MEMBERSHIP AND THE DUTIES OF THEIR OFFICE. ALSO, A COPY OF THESE LAWS SHALL BE MADE AVAILABLE UPON REQUEST TO ANY MEMBER IN GOOD STANDING.
